Code Enforcement by Jack Daniels

Housing Rental Matters: In the present economy, it may become necessary to supplement one's income. Some home owners have "rented" out rooms or spaces within their homes to provide some additional income. As one can imagine, there are inherent concerns with this on many levels. One concern is that concerning the overall safety of everyone within the home. Some safety tips are as follows:

- The new occupant needs to be viewed as a family member; this means that they need to have all of the access to certain areas of the home that a true family member would have such as use of a bathroom & kitchen.
- The sleeping area for the new occupant must be the same as that of a true family member; use of a room that is not a legitimate bedroom is not permitted.

- The door to the sleeping room of the new occupant must not be subject to being locked and secured from outside of the room itself; doing so indicates a rooming house arrangement and there are many code and liability matters that present themselves is this arrangement occurs, the door is permitted to be lock from the inside but not the outside.
- Familiarize the new occupant with the fire safety aspects of the house including alarms and escape drills.

These are just some of the issues that any home owner needs to be conscious of. Always conduct background checks and inform your insurance company of renting out space within your home.

Rental apartments or houses – the annual registration of these is due by March. Notices have been sent out and updating the information on these forms is imperative. At certain instances, an

inspection may be necessary before a certificate can be issued. There are certain safety aspects that are in need of being verified during an inspection. Some of these include properly placed and functioning smoke and carbon monoxide detectors, a properly installed fire extinguisher, GFI (ground fault outlets) near water sources (bathroom/kitchen), properly functioning heating systems, etc.

Afterwards the water and gas lines will be put in, then curbs, sidewalks and finally the paving. We expect to be complete in the Spring and it should look very nice.

We know how vital it is to do this project swiftly and with as little negative impact on the business district. Like a shopping mall owner we want to make sure we provide a quality service and enhance the over all Town center. Shopping downtown by all members of the public is greatly encouraged as the business's help our tax base and the value of our homes. For the Business', Landlord's and Townsfolk it is an investment worth making. As these

In late Spring we look to repave Leigh Street and the State DOT will be repaving Old Route 22/West Main street. Those dates will be managed so not to conflict with our work downtown.

Public Works / Bus. Administrator by Richard D. Phelan



I am very pleased and honored to be your new Public Works/Business Administrator for the Town of Clinton. Since my employment on March 1st, I have been welcomed by residents and staff alike, which is a testament to the courteousness and professionalism of the Town. I am eager to strengthen all the good aspects that Clinton is known for and look forward to working with everyone.

To that end, we start 2012 with several large and important projects in the community. If you recall, a new 2.5 million gallon water storage tank was constructed to provide additional capacity during peak usage. Now that the new tank is operational, we have begun maintenance and repairs to the original tank. The goal is to have both tanks fully operational

later this year.

Nearly all of the work on the Leigh Street Water Main Replacement Project has been completed. The final item, which is the repaving of the road itself, will occur in the Spring after the trenches have had sufficient time to settle.

The preconstruction meeting for the improvements to the Wastewater Treatment Plant Filter Replacement Project will take place soon. Shortly thereafter the work can commence.

One of the final projects, and most noticeable is the infrastructure improvements that are being done downtown. The goal of this construction is to improve both underground and above-ground infrastructures in the areas, such as water and storm sewer sys-

tems and road resurfacing. The Town is working very closely with the contractors to ensure that there is as little impact as possible to residents, businesses and visitors during the construction, but some interruptions will be unavoidable. We thank everyone in advance for their understanding and cooperation during this project.

The Town has affordable housing units available for purchase and recently added two rental units. If you know anyone who may be eligible to qualify for affordable housing, please visit the Clerk's Office to fill out an application. These units offer a valuable opportunity for income qualified participants. Units are currently available for both low and moderate income levels.

Recreation Commission by Rich Duffy

Fire Commission by Rich Duffy

The Clinton Fire Department responded to 365 calls in 2011. This is the highest recorded number of calls for the fire department ever. The Clinton Fire Department has been a long time participant in shared services through a mutual aid agreement with many of our surrounding towns. These towns also reciprocate with assistance to the Clinton Fire Department. The CFD handled 120 calls on our own, received mutual aid on 110 calls and provided mutual aid 135 times. Of the 365 calls, most are Level 1 calls, 284, of minor nature which may include auto accidents, fire alarms or minor outdoor

fires. Level 2 calls are more involved which may include chimney fires, smoke odors, appliance fires, etc and included about 9 calls. The more serious fire calls, Level 3, which include structure fires, smoke in building, gas leaks, etc., resulted in 57 calls.

Thanks to former Chief, Scott Wintermute, for providing the statistical data. Scott also drilled down further in his analysis and found that our busiest day of the week was Sunday, with 64 calls and the slowest day of the week was Wednesday with 39 calls. The average response time from dispatch until on scene was just under

7 minutes. On average, the members of the CFD, an all volunteer group, spent about 35 minutes on scene for these calls.

In addition to responding to fire calls, the members of the Clinton Fire Department accumulated over 865 man hours in training.

The CFD wants to remind you to change the batteries in your smoke and carbon monoxide detectors when you set your clocks back for daylight savings time. Remember to also change the batteries in hard wired units that have battery back-ups.

PEDESTRIAN SAFETY

Clinton is a pedestrian friendly Town and it's extremely important that both pedestrians and motorists are aware of their separate but equal responsibilities at crosswalks. Pedestrians must **STOP** at the curb, look both ways and proceed only when safe to do so. Motorists must **STOP** for a pedestrian who has entered the crosswalk, and may proceed only when the pedestrian is clear of it. **After dark, pedestrians should wear light or reflective clothing** and motorists should pay extra attention at intersections and crosswalks for the unexpected. Bicycles operated after dark are required to be illuminated with some type of headlight and reflectors in addition to obeying all other traffic laws. If a bicyclist, pedestrian or motorist neglect a responsibility the results can be tragic and expensive for both. Every year hundreds of pedestrians are injured and many are killed nationwide, that's why the Town and its Police Department take their safety very seriously and we actively enforce laws related to their safety.

HOUSE NUMBERS

Emergency responders **STILL** are having difficulty quickly locating some emergency calls at homes throughout Town because those properties are not properly marked with a street address that can readily be identified from the street or sidewalk. When an emergency happens seconds are critical to responding police, fire or rescue personnel. Please take the time to check your property to make sure that your house, apartment or building number is clearly marked and visible from the street so that those critical seconds can be spent on your emergency and not trying to find it!

OVERNIGHT PARKING RESTRICTIONS

Winter overnight parking restrictions for this season will end March 31st, but until then please do not park on any street in Town between 0200am and 0600am when snow is forecast during those hours or streets are already snow covered. Your car will receive a summons and may be towed at your expense.

CELL PHONES & TEXTING WHILE DRIVING IS DANGEROUS AND EXPENSIVE

If you think your cell/texting bill was expensive last month, wait until you pay a \$100.00 ticket for getting caught using it while driving in our Town! Clinton is too busy and too small for motorists to be paying attention to anything other than driving. WWW.NJSAFEROADS.COM.

SKATEBOARDS, SKATES, ROLLERBLADES and SCOOTERS

The Town receives hundreds of complaints and inquiries every year regarding laws governing skateboards, skates, scooters and other locomotion devices that are gas or electrically powered. Skateboards, skates and non-motorized scooters are considered "human powered" locomotion devices. They are prohibited from being operated on any street, highway or other area of Town designed for motor vehicles by ordinance. Additionally they are prohibited from being operated on the sidewalks of Main Street, Lower Center Street, East Main Street and the section of Leigh Street from Route 173 to Center Street. Although they are sold in stores and on the internet, gas or electrically powered skateboards, scooters or any other "motorized" locomotion device are considered motor vehicles under current law and

the operation of such powered devices is prohibited on any public street or sidewalk in New Jersey. Operation of these motorized devices on public streets can subject the operator to being charged under State motor vehicle law with operating an unregistered and uninsured vehicle in addition to any other traffic violation they may be committing, **REGARDLESS OF AGE**. If you have ANY questions regarding ANY motor vehicle law or Town ordinance regulating any of these devices **PLEASE ASK** an officer **FIRST**. Also, please remember that if you are under 18 years of age you **MUST** wear an approved helmet, even on a bicycle.

FINGERPRINTING

Fingerprinting is required for a variety of public and private purposes. If you live in Clinton or your employer is in Town you may schedule an appointment to be fingerprinted by calling 908-735-2665 ext. 215 and leaving a message for Detective Sergeant Jay Hunter or Patrolman Jim Kramer.

Clinton First Aid & Rescue Squad by Chad Newsome



We all share the responsibility of knowing and practicing proper driving behaviors. One of the most important "rules of the road" deals with yielding the right of way to emergency vehicles. Each day, emergency vehicles respond to urgent requests from the public. The call may be for a person that has stopped breathing, a fire alarm or a car accident. It is the concern of all Emergency Service agencies that response time to call locations be minimized. Precious minutes that are lost while driving to an emergency could be the difference between life and death.

With the advent of new sound-proof cars, high-decibel stereo systems, cell phones and, unfortunately, drivers who simply don't care about anyone but themselves, the idea of getting to an emergency scene quickly, safely and efficiently is very difficult. Many times we are often faced with drivers who cannot see or hear us. This creates an incredibly frustrating situation for the emergency vehicle driver as they weave their way through traffic.

All drivers must know their responsibilities when approached by an emergency vehicle with its red lights flashing or siren sounding.

What Drivers Should Do:

- Remain calm. Don't panic!
- Pull to the right and come to a stop.
- When on a high-speed road or when there is no room to stop, slow down as much as possible.
- When in the left lane, pull over into the right lane as the traffic in

the lane to your right moves over.

- If you cannot move to the right because of an obstacle such as a car to your right, simply stop.
- Your prompt action will let the driver of the emergency vehicle know what you are doing; it will allow the driver to anticipate where to drive.
- When an emergency vehicle approaches you from behind while you are stationary at an intersection stop sign or red light, do not move unless you can pull to the right.

What Drivers Should NOT Do:

- Don't stop in the middle lane when there is room to pull to the right.
- Don't pull to the left in the center lane or left turn lane.
- Don't drive through a red light or stop sign when an emergency vehicle approaches from behind.
- Don't turn quickly to the left into a driveway or street.
- Don't race ahead to get through a green light or turn before the emergency vehicle gets there.
- Don't disregard the presence of the emergency vehicle by continuing to drive.

In heavy traffic, motorists in the right hand lane must pull as close to the curb as possible with motorists in the left hand lane pulling as close as possible to them. The law states that traffic in both directions must pull to the right and stop. When they do, there is room for the emergency vehicle to pass safely.

Motorists are obligated by law to

check what is happening behind them before making a left turn. Left turns must always be aborted if an emergency vehicle is approaching from behind. The motorist should usually proceed straight through the intersection, then pull to the right and stop. The motorist must abort the left turn, by pulling to the right and stopping, being sure, of course, not to block the intersection.

When motorists see an emergency vehicle approaching, they pull to the right and stop before they get to the intersection. They do not turn or go until they are sure all emergency vehicles have passed. Traffic in both directions must yield to an emergency vehicle. This is critical at intersections. Motorists should pull to the right and stop before they get to the intersection--and must always yield to an oncoming emergency vehicle making a left turn.

The law requires you to pull to the right and yield to an emergency vehicle, even before it gets on the road. Be alert. When you see that a fire truck or ambulance is coming out of its station, pull to the right and stop.

Pedestrians are also required to get out of the way for an emergency vehicle. If, as a pedestrian, you are already on the road, get off the road as soon as possible. If you are about to cross and you see or hear an emergency vehicle approaching, don't go on the road--stay on the sidewalk until the emergency vehicle has passed.

Please consider all of the above the next time you see the Clinton First Aid & Rescue Squad – or any emergency vehicle – responding to a call. The call for help could be for one of your friends or family members. Your assistance is greatly appreciated!

ATTENTION DOG OWNERS - PLEASE CURB YOUR DOG

The Town of Clinton would like to remind you of a important responsibilities as a pet owner:

1. You must pick up after your dog to protect the health, safety and welfare of our residents.
2. You must control the barking of your dog according to the Town's Noise Ordinance.



Council Highlights by Sue Komorowski

November 22, 2011

~Resolution adopted to re-appoint the Joint Municipal Tax Assessor between the Township of Tewksbury and the Town of Clinton.

~Resolution to request additional 35-day extension from the NJDOT to award a contract for repairs to Lower Center, Main, and East Main Street improvements.

~Kathy Olsen, CFO, reported on the League of Municipalities, stating it is not clear which municipalities will receive state aid. Pending Legislature includes that bids will be required to be posted on the State website, but municipalities would be responsible for posting and removal from that site. Towns are now able to lease advertising space on their web sites. Towns may have to pay interest on the 2% held to contractors.

~Mr. Cushing explained a new law requires permits for used clothing bins in Town due to concerns of using those bins for non-charitable purposes. Ordinance will be introduced in the New Year, and a permit application developed.

~On November 26th, there will be a 150th Celebration of the Leigh Mansion, with Town Historian, Allie McGaheran giving a brief history of the Leigh Mansion.

December 13, 2011

~Adopted Resolution to preserve the Town of Clinton's 2011 Open Space funds.

~Contract awarded to Z Brothers for the Lower Center, Main and East Main Streets Improvements Project.

~Resolution for the Town to commit to maintaining the Safe Routes to School Project, which includes repairs to the

sidewalk between the Clinton House and New Street.

~MaryAnn Shea appointed to Board of Recreation Commission.

~Resignation, with regrets, of Rodney Hendricksen after 3 decades on the Planning Board.

~Rescue Squad calls are down compared to same time last year, as are fundraising contributions. Eight members are now certified in confined space training.

~Per Clinton Guild, downtown Clinton reported a good shopping season, and the success of events such as "Passport to Clinton" and "Doing Clinton"

~Adopted Resolution to appoint Peter Jost, Esq., to act as Special Counsel for the Town relating to residential tax appeals during the year 2011.

~The 4th Annual Bonfire will be on January 21, 2012.

December 27, 2011

~Resolution made to award waste and recycling contract to Premier Disposal, Inc for 1 year.

~Adopted Resolution to reject downtown water main bids due to a procedural requirement not being consistent with NJ State Public Contracts Law. Project will be re-bid.

~Resolution adopted to enter into Shared Services agreement for the operation of the Clinton Twp. Sanitary Sewerage Collection System.

~Mr. Naples explained the Town has saved by obtaining quotes through Goldstar Energy Group to lower electricity and natural gas for the Town.

~Council accepted resignation with regret from William Kruetel who served as a member of the Clinton Environmental Commission.

January 2, 2012

~Reorganization meeting.

~Outgoing Mayor Richard Miller expressed his deepest appreciation to colleagues, the Town staff, and the Public Works employees for their acceptance and assistance during his position of interim mayor.

~Swearing in of Mayor Janice Kovach.

~Swearing in of Councilwoman Valenta and Councilman Pendergast.

~Mayor Kovach announces James Naples will be leaving his position of Public Works/Business Administrator and returning to the Township of Bridgewater.

January 10, 2012

~Mr. Naples reported the final recycling tonnage numbers are in for 2011 showing a 28% increase in recycling. 321 tons is the highest recycling numbers ever for the Town.

~Councilman Shea reported that West Main Street will be repaved between April & August 2012 by DOT.
